LETTER OF AUTHORITY ISSUED BY THE IMPERIAL KINGDOM OF NUMIDORIA

THE FOUNDING CHARTER OF THE IMPERIAL CULTURAL & HERITAGE SEAT OF NUMIDORIA

Established upon the Halaib Triangle & Bir Tawil Territory
By His Imperial Royal Majesty Muja'Dib Jamel Ben Ha'Melek El'Sori-Oser VIII
Senior Emperor of the African Diaspora & Sovereign of Numidoria

PREAMBLE

In the Name of the Most High, the Great I Am,
I, His Imperial Royal Majesty Muja'Dib Jamel Ben Ha'Melek El'Sori-Oser VIII, Senior Emperor of the African Diaspora and Sovereign of the Kingdom of Numidoria, hereby establish a Cultural and Heritage Seat upon the territories commonly known as the Halaib Triangle and the Bir Tawil.

Whereas the descendants of the African diaspora, dispersed across continents by forced migration, colonization, and historic injustice, retain the ancestral right and heritage of their forebears;

Whereas the Numi Kingdom — historically rooted in the legacy of ancient African sovereign polities, and restored to global presence under the name “Numidoria” — claims cultural, hereditary, and sovereign legitimacy through the Royal House of El'Sori-Oser;

Whereas the Numi Kingdom has established, since 2017, a structured sovereign framework — inclusive of a Royal House, a Virtual Embassy, ministries, constitutional-cultural charter, naturalization and passport services, and global enterprise arms — to serve the African Diaspora and uphold ancestral governance, dignity, and unity;

Whereas recognition of sovereign lineage beyond geographic constraints is a widely respected precedent for diasporic and displaced royal houses, affirming that heritage, bloodline, and royal authority transcend birthplace and diaspora status;

Whereas the Numi Kingdom aspires to foster unity, healing, cultural preservation, economic empowerment, and diplomatic cooperation among African nations, diaspora communities, indigenous groups, and global partners;

Now, therefore, by virtue of ancestral inheritance, sovereign restoration, and collective will of the diaspora peoples, the Numi Kingdom declares itself a legitimate, autonomous, hereditary monarchy. It affirms its readiness to engage peacefully with foreign powers, institutions, and nations — to uphold treaties, alliances, cultural exchange, economic partnership, and mutual respect — in the spirit of global dignity, historical justice, and diaspora solidarity. So let it be known that the Numi Kingdom stands as a restored sovereign entity: guardian of heritage, voice of the diaspora, architect of unity, and partner in global cooperation.

These lands—one disputed, one unclaimed—have remained without a unified cultural mandate or diaspora stewardship. As the descendants of ancient African monarchs reclaim their historical identity and dignity, it becomes necessary to designate a symbolic homeland for the restoration of African dignity, lineage, sovereignty, and spiritual heritage.

This charter does not seek to interfere with or violate the sovereign claims of any modern nation-state. Instead, it establishes a Non-Political, Cultural, Royal, and Humanitarian Jurisdiction dedicated to the African Diaspora worldwide.

ARTICLE I – PURPOSE OF THE HERITAGE SEAT

1. To establish a permanent royal cultural territory representing the African Diaspora under the Crown of Numidoria.
2. To restore ancient African identity, royal lineage, historical memory, and spiritual sovereignty.
3. To create a homeland of cultural unity, peace, humanitarian progress, and diasporic renewal.
4. To provide a location for royal ceremonies, cultural gatherings, imperial convocations, and scholarly institutions tied to African civilization.
5. To ensure that the African Diaspora has a sacred place on the African continent tied to its spiritual and ancestral restoration.

ARTICLE II – TERRITORIAL DESIGNATION

1. The Halaib Triangle

Recognized internationally as a disputed territory between Egypt and Sudan; however, neither party holds uncontested sovereignty.

Under this charter, Halaib shall serve as:

The Federated Coastal Cultural Territory of Numidoria

A seat for maritime heritage, Red Sea cultural exchange, and royal diplomatic ceremonies

A symbolic center of Nubian–Kushitic royal legacy

This symbolic designation does not challenge or oppose Egypt or Sudan but establishes a cultural and humanitarian zone under Numidoria's Crown-Sanctioned Cultural Mandate.

2. The Bir Tawil Triangle

An unclaimed land (terra nullius) under international law.

Under this charter, Bir Tawil shall serve as:

The Imperial Spiritual Sanctuary of Numidoria

A sovereign cultural homeland for the African Diaspora

A neutral sacred territory for pilgrimage, royal rites, and heritage restoration

A site for developing humanitarian, archaeological, environmental, and educational initiatives

This designation respects the neutrality of the land and does not constitute political annexation.

ARTICLE III – NATURE OF AUTHORITY

The authority exercised by the Crown of Numidoria over these territories is:

Cultural Authority – not governmental

Heritage Authority – not political annexation

Diaspora Mandate – not state territorial claim

This is a royal, spiritual, historical, and cultural jurisdiction that operates independently of politics and without conflict with Egypt, Sudan, or any recognized state.

ARTICLE IV – INTENDED DEVELOPMENT

Under the authority of His Imperial Majesty, the territories shall be developed as:

1. A Royal Cultural Capital of the African Diaspora
– **Housing museums, archives, temples, libraries, and cultural institutions.**
2. A Humanitarian Free Zone
– **Hosting relief programs, diaspora housing projects, and development centers.**
3. A Diplomatic and Cultural Conference Territory
– **For inter-African and diaspora leadership gatherings.**
4. An Imperial Sanctuary
– **Reserved for rites, coronations, royal investitures, and ancestral observances.**
5. A Heritage Research Zone
– **Dedicated to archaeology, anthropology, historical preservation, and Nubian-Kushitic scholarship.**

ARTICLE V – PROTECTION OF THE TERRITORIES

The Crown pledges:

1. Non-Interference Clause:

The Cultural Seat does not seek political sovereignty against Egypt, Sudan, or any nation.

2. Humanitarian Neutrality:

The territories shall remain free of political conflict, military engagement, and ideological alliances.

3. Environmental Preservation:

Development shall respect ecological integrity and indigenous traditions.

4. Royal Guardianship:

The Head Queen and the Royal Council shall oversee all cultural and spiritual functions within the territory.

ARTICLE VI – DEDICATION

Let this charter stand as a sacred restoration of African identity, a renewal of the Kushitic, Nubian, and Numidian legacies, and a home for the descendants of Africa scattered across the world.

By the authority vested in me through royal lineage, divine providence, and ancient mandate, I establish this Cultural and Heritage Seat forevermore.

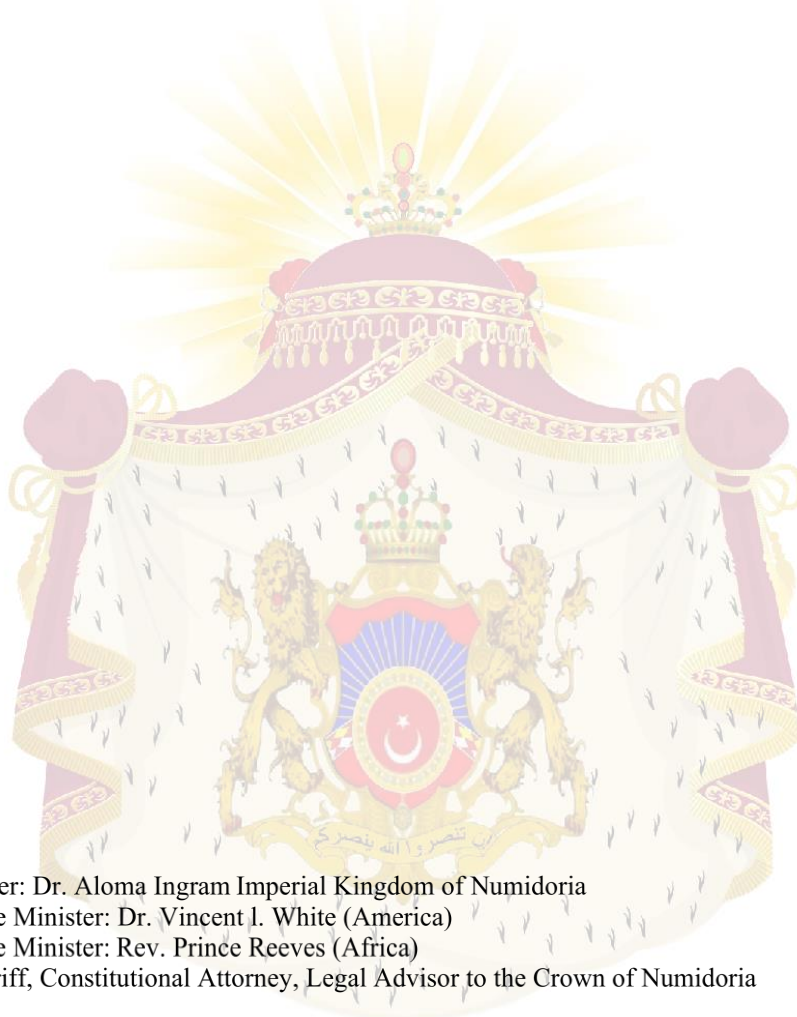

The Numi Kingdom of the Fulani Realm, under the Royal House of Muja 'Dib El Sori, asserts its sovereignty in accordance with customary international law. This sovereignty is recognized under the framework of the United Nations Diplomatic Relations (Preamble, Article 47.1) and the UN Consular Relations, which affirm that a sovereign "subject of international law" is binding upon all states, irrespective of formal recognition (UN Law, Article 17.1). As a non-territorial state, the Numi Kingdom operates within the provisions of the UN Diplomatic Relations (Articles 1(i) and 3.1(a)). It is established as the "Kingdom" of the African Diaspora and Numidia people, a designation supported by the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP, Articles 3, 4, 5, 9, 33, 36, and 37). The Numidia people, recognized as an indigenous ethnic and spiritual community, are further protected under international law, as affirmed by the Great Seal National Association of Cultural Affairs (2019, p.11) and UNDRIP Article 8. This preamble affirms the sovereignty, rights, and international legal standing of the Numi Kingdom, guided by the enduring principles of equity, self-determination, and cultural preservation under the framework of international law.
